### OverDrive™ System, TorkDrive™ Tool Enable Efficient Installation of Casings and Liner, Saving Rig Time and Associated Costs

#### Objectives

- Install a 13 3/8-in. casing, a 9 5/8-in. casing, and a 7-in. liner to facilitate efficient and cost-effective drilling of an exploration well.

#### Results

- Weatherford deployed its *OverDrive* casing-running system and *TorkDrive* tool were used to successfully drill the exploration well and install a 13 3/8- and 9 5/8-in. casing with a 7-in. liner.
- The *OverDrive* and *TorkDrive* systems enabled the operator to reduce the number of personnel required on the deck for optimal safety.

#### Value to Client

- Using the *OverDrive* system and *TorkDrive* tool saved an average of 7 to 9 hr rig time and associated costs for each casing installation, enabling the operator to successfully drill a new exploration well.
- Using *OverDrive* and *TorkDrive* technology required only three to five personnel for each run, reducing manual handling of tubulars and the number of personnel on the rig floor.



Mounted to the rig's top drive, the remotely operated *TorkDrive* tool combines several conventional casing-running tools (power tong, elevator, and fill-up/circulation tool) into one. The *TorkDrive* tool is available in external or internal gripping models to accommodate a wide range of casing sizes. The reduced size makes the *TorkDrive* tool very efficient for rig up/down and the ideal tool for land-rig applications.
